The product has a 1:1 liquid mix ratio by volume. Mix only an amount of material that can be used in 1-3 minutes.

- 1) Mix the liquids (1 part Part A and 1 part Part B) for 15 seconds
- 2) Add in the desired amount of CP Decorative Texture Mix to thicken and remix.
- 3) Immediately after the three components are mixed, (Product has a very short pot life), place the material into the area to be repaired with a trowel or other suitable equipment.
- 4) Trowel the floor to smooth out the area and remove any excess material.
